



2021 CAMPER APPLICATION For Groups

- As covid-19 vaccinations and guidelines continue to evolve, Yakima County is allowing camp operations on a modified basis. We continue to ask you to evaluate your own personal comfort level and ability to attend camp. The CDC identifies several underlining condition regarding at risk populations. They include underlying medical conditions, age, ethnicity, disabilities, and development/behavioral disorders.
- Groups are required to provide group name, two contact persons, address, phone numbers and email addresses.
- Camp Prime Time requires a **\$25.00 deposit from each family** planning to attend prior to attendance at camp. These refundable deposits are deposited once we receive them. Each camper family has the opportunity for a deposit refund after their weekend at camp.
- **New in 2021** – Once a camp session is confirmed we will provide group leaders a link and password for online registration of families. Please do NOT give out your password. This is for the group leaders to make needed changes and updates to information provided by camper families and to assign cabins.
 - 1) ALL family members must be registered with current addresses and ALL family member's correct birthdates.
 - 2) List all special dietary needs of **any** family member so that we can do our best to accommodate our campers.
 - 3) Have your **families on the wait list** register too, in the event a confirmed family cancels.
 - 4) Gather your camper families \$25.00 deposit and mail in one (1) month prior to your assigned weekend.

If we do not receive your group's online registration, by **May 1, 2021**, we assume your group is no longer interested in attending and may assign your weekend to the next group on our waiting list.

Please indicate three (3) preferred dates for Camp Sessions. Sessions begin the first weekend in June and run through the first weekend of October. **Submitting this form does not guarantee placement.** Priority for sessions: 1) Groups with illnesses impacting life expectancy, 2) New Groups, 3) Groups not attending the previous year.

Always apply. All group applications are put on the waiting list in event of cancellations or unfilled cabins.
